Dear Members of the State Budget Committee:

I am submitting this letter for the purpose of expressing some concerns I have regarding the duties and responsibilities we collectively share as members of the State Budget Committee.

According to Rule 10(I), the State Treasurer shall disburse funds of the State Committee and Oklahoma Republican Party "...in accordance with budgets established by the State Budget Committee". The rule goes on to state "The accounts of the Treasurer shall be accessible at all times to...any member of the State Finance or <u>Budget Committee</u>...", as well as "All disbursements shall be made in accordance with the law and these rules". To my knowledge, we, as a body, have not held a meeting and set a budget for disbursement of funds yet funds are being disbursed.

Additionally, Rule 13(b) states that "All funds collected by the Oklahoma Republican Party shall be deposited in an account subject to disbursement by the State Chairman, subject to the advice and consent of the State Budget Committee...". Once again, to my knowledge, we collectively have not held a meeting to give our advice or consent to any disbursements.

Furthermore, Rule 14(b) states "It shall be the responsibility of the State Budget Committee, and it shall have the <u>power and authority</u>, to prepare budgets designating the amount, classification and priority of expenditures to be made from funds of the Republican State Committee, giving due consideration to the estimated availability of funds".

I would also like to point out that there is no enumerated mechanism within our State Party Rules for calling a meeting of the State Budget Committee so we may need to propose that at our next State Convention. That said though, according to Rule 20(c), "All question of procedure and other matters affecting the Oklahoma Republican Party...which are not specifically covered in these rules shall be governed by Robert's Rules of Order, Newly Revised...". Referring to Robert's Rule 50:21 (Page 475-476), "If some members of the committee believe that the chairman has failed to call this initial meeting...a meeting of the committee may be called by any two of its members...". Technically speaking, the State Budget Committee being a (Robert's Rule 13:18) committee named by a power other than the chair, "...the first-named member has the duty of calling the committee together and of acting as temporary chairman until the committee elects a chairman".

Please understand that I raise awareness of this issue with the most honorable of intentions. If we are to be the party of law and order, we must adhere to our own rules and set a proper example for our fellow party members. We must also strive for accountability and transparency. Anything less would be a mockery of the principles we all claim to share.

I submit this to each of you respectfully.

#### **Rule 10-State Committee**

(I) Duties of State Treasurer: The State Treasurer shall be the custodian of all funds of the State Committee and the Oklahoma Republican Party and shall disburse the same in accordance with budgets established by the State Budget Committee. The State Treasurer shall keep a strict account of all receipts and disbursements, with the dates thereof, from whom received and to whom disbursed, and the purpose thereof. The accounts of the Treasurer shall be accessible at all times to the State Chairman and Vice Chairman, or any member of the State Finance or Budget Committees or any representative of any of said officers or committees duly authorized in writing by such officer or committee. All disbursements shall be made in accordance with the law and these rules. The State Treasurer shall report at such time or times as requested by the State Budget Committee in such form as will provide all necessary information relative to the amount of receipts, disbursements and cash balance, together with expenditures charged to each item of the budget and the unexpended balance of the budget items. At any time, if required by the State Budget Committee, the State Treasurer shall furnish a good and sufficient bond payable to the Oklahoma Republican State Committee for the faithful performance of the duties and due accounting for all money and property entrusted to the Treasurer, in such amount as may be required by the State Budget Committee and be generally approved by said committee. At the end of the term of office, the State Treasurer shall deliver to the successor all monies, property, books, and records of the State Budget Committee and the Oklahoma Republican Party, maintained by or in the possession of the State Treasurer.

#### **Rule 13-State Finance Committee**

- (a) Composition, Term, and Vacancies: There shall be a State Finance Committee composed of not less than twice the number of Congressional Districts in the state and not more than one hundred (100). In addition to the above members, there shall be a State Finance Chairman, and if desired, a State Finance Vice Chairman. They shall be appointed by the State Chairman, as soon as possible (not to exceed sixty (60) days after the regular biennial State Convention, subject to the approval of the State Committee, and shall serve at the pleasure of the State Chairman. Any vacancy shall be filled in the same manner as an appointment is made. The State Chairman and Vice Chairman, Oklahoma Republican National Committeeman and Committeewoman, and State Treasurer shall, by virtue of their office, also be members of said committee, and shall have the same power and authority as the other members.
- (b) Authority and Duties: It shall be the duty of the State Finance Committee to devise ways and means to properly finance the Republican General Election campaigns and other Republican Party business and affairs. The State Finance Committee shall have authority to establish quotas on an equitable basis designating the responsibility of each county within the state to provide the funds required to meet Republican Party organizational needs, and to cooperate with county organizations in determining the financial requirements of local organizations, and to effect agreements between the State Finance Committee and county Republican organizations for equitable division of funds raised within each county. It shall have the authority to communicate in the name of the committee with such persons as it shall deem necessary for the purpose of promoting the business and general welfare of the Republican Party, and to raise funds for general election campaigns.

The State Finance Chairman shall have the authority and responsibility for details involved with committee-sponsored or statewide fundraising events, including the collection and accountability for the proceeds therefrom. Requests for presidents, vice presidents, cabinet members, governors, senators, and representatives for the state party fundraising events shall be made through either the State Finance Chairman or State Headquarters. Said committee shall not, however, directly or indirectly, raise or collect, or attempt to raise or collect funds for the benefit of any candidates (county, state or national) for primary elections.

All funds collected by the Oklahoma Republican Party shall be deposited in an account subject to disbursement by the State Chairman, subject to the advice and consent of the State Budget Committee, in the manner hereinafter provided. At such periodic intervals as may be determined by the State Budget Committee, there may be disbursed to the county Republican organizations such portion of funds collected within the county involved as shall have been agreed upon in writing between the State Finance Committee and the County Chairman and County Finance Committee, or as shall have otherwise been determined by the State Finance Committee. Payment of the necessary and proper operating expenses of the State Finance Committee, within limits authorized by the State Budget Committee, shall be made from funds in possession of said committee. At such periodic intervals as shall be directed by the State Budget Committee, the remaining funds collected by the State Finance Committee shall be transferred to the State Treasurer, who shall disburse it only in accordance with law and these rules.

#### **Rule 14- State Budget Committee**

- (a) Composition, Term and Vacancies: There shall be a State Budget Committee of the State Committee composed of the State Chairman, the State Vice Chairman, the Oklahoma National Committeeman and Committeewoman, the Treasurer of the State Committee, and the Chairman of the State Finance Committee, together with nine members, at least one of whom shall be nominated by the members of the Congressional District Committee of each Congressional District, to be elected by the Congressional District Committee as soon as possible (not to exceed sixty (60) days) after the regular biennial State Convention, whose term of office shall begin upon their election and continue until the adjournment of the next regular biennial State Convention and their successors are elected and qualified. A vacancy in any position of such elected members shall be filled for the unexpired term by election by the Congressional District Committee at any regular or special meeting thereof. Any remaining members after those nominated by the members of the Congressional District Committees of each Congressional District shall be jointly filled by the State Chairman and Vice Chairman. If they cannot agree on such appointment, then they shall be evenly appointed between the State Chairman and Vice Chairman, in the event that there is an odd number remaining, the State Chairman shall make the extra appointment.
- (b) Authority and Duties: It shall be the responsibility of the State Budget Committee, and it shall have the power and authority, to prepare budgets designating the amount, classification and priority of expenditures to be made from funds of the Republican State Committee, giving due consideration to the estimated availability of funds. By appropriate actions and resolutions it shall prescribe rules and regulation governing the fiscal affairs of the Republican Party organizations, including the procedure required for recommendations to the State Committee of amounts to be included in budgets and the incurring of obligations under such budgets. Said committee shall not authorize, directly or indirectly, any budget for, or expenditures of, funds for any candidate or candidates for any Primary election campaign, or the expenses thereof, whether such expenses incurred before, during, or after such Primary election.

It shall be the duty of said committee to evaluate the procedures and records of the State Treasurer and the State Finance Committee, and to make a report of such evaluation to the State Chairman, and State Committee annually, or more often as deemed necessary by the Budget Committee, or when requested by the State Chairman, or State Committee.

(c) CPA Financial Review: The financial books and records of the Oklahoma Republican Party, including the State Committee, the State Finance Committee, the Candidate Reserve Fund, and all other funds established by the Oklahoma Republican Party, shall be reviewed by a certified public accountant chosen by the State Budget Committee within a reasonable time after a new chairman is elected. A biennial review shall be conducted immediately preceding the biennial State Convention and shall cover the two year period ending January 31 of the Biennial Convention year. The review shall be conducted in accordance with generally accepted accounting principles as established by the American Institute of Certified Public Accountants. The completed review shall be submitted to the State Chairman, the State Budget Committee, and the State Committee.

Such a review may also be conducted at any other time as deemed necessary by a majority of those present and voting at a State Budget Committee or State Committee meeting, provided a quorum is present at the meeting.

**(f) State Budget Committee Review:** The financial records of the Oklahoma Republican Party including the State Committee, the State Finance Committee, the Candidate Reserve Fund and all other funds established by the Oklahoma Republican Party, and in addition, a complete inventory of all equipment and all property owned or leased by the Oklahoma Republican Party, shall be examined by the State Budget Committee, and shall cover the two-year period ending with the even-numbered years. The completed examination shall be submitted to the State Chairman, and the State Committee.

Such a review may also be conducted at any other time as recommended by the State Budget Committee or the State Committee.

### **Robert's Rules of Order**

Newly Revised - 12th Edition

#### Rule 13:17 (Page 164-165)

Designating the Committee Chairman. If the chair appoints or nominates the committee, he has the duty to select its chairman – which he does by naming that person to the committee first – and the committee cannot elect another. The chair should not state the name of any committee member until he has decided his preference for chairman. The chair should specifically mention as chairman the first committee member he names, but if he neglects to state this fact, the designation nevertheless is automatic unless the first-named member immediately declines the chairmanship (which the member can do, and remain on the committee). If the first-named member declines to serve as chairman, the chair then names his next choice for this position. If the committee's task is heavy and will require some time to complete, it often is advisable to appoint a vice-chairman. The anomalous title "co-chairman" should be avoided, as it causes impossible dilemmas in attempts to share the functions of a single position.

#### Rule 13:18 (Page 165)

If the committee is named by a power other than the chair (such as the assembly or the executive board), the body that elects the committee members has the power, at the time the appointments are made, to designate any one of them as chairman. If a chairman is not designated when the committee is appointed, the committee has the right to elect its own chairman. In the latter case, the first-named member has the duty of calling the committee together and of acting as temporary chairman until the committee elects a chairman. Since such a committee may confirm its first-named member in the chairmanship, it is important that this person be qualified and dependable.

#### Rule 50:4 (Page 466)

Generally the term *committee* implies that, within the area of its assigned responsibilities, the committee has less authority to act independently for the society (or other constituting power) than a board is usually understood to have. Thus, if the committee is to do more than report its findings or recommendations to the assembly, it may be empowered to act for the society only on specific instructions; or, if it is given standing powers, its actions may be more closely subject to review than a board's, or it may be required to report more fully. Also, unlike most boards, a committee in general does not have regular meeting times established by rule; but meetings of the committee are called as stated in 50:21-22. Some standing committees, however – particularly in large state or national organizations – function virtually in the manner of boards, although not designated as such.

#### Rule 50:5 (Page 467)

When a committee is appointed "with power", this means with power to take all the steps necessary to carry out its instructions.

#### Rule 50:21 (Page 475-476)

**Committee Meetings.** When a committee has been appointed, its chairman (or first-named member temporarily acting – see 13:18) should call it together. If some members of the committee believe that the chairman has failed to call this initial meeting or any subsequent meeting when necessary, a meeting of the committee may be called by any two of its members, unless (such as for very large committees) the assembly's rules or instructions prescribe, or empower the committee itself to require, a larger number. It is the responsibility of the person or persons calling a committee meeting to ensure that reasonable notice of its time and place is sent to every committee member. The quorum in a committee is a majority of its membership unless the assembly has prescribed a different quorum (40).

- Roberts Rules of Order Newly Revised 47:11 Section 3

  An elected chairman pro tem. If neither the president nor any vice-president is present, the secretary or in the secretary's absence some other member calls the meeting to order, and the assembly immediately elects a chairman pro tem to preside during that session. Such office is terminated by the entrance of the president or a vice-president, or by the adoption of a motion to "declare the chair vacant and proceed to elect a new chairman" (see 62:11). If the assembly is to elect a chairman pro tem to hold office beyond the current session (in the event that the president and the vice-presidents are unable to perform their duties for that length of time), notice must be given at the preceding meeting or in the call of the meeting at which such election is held.
- Roberts Rules of Order Newly Revised 47:34

  In the absence of the secretary, a secretary pro tem must be elected; the corresponding, financial, or executive secretary in organizations having such officers is not an automatic replacement. If, under "Reports of Officers" in the order of business, correspondence of an official character is to be read, it is normally read by the recording secretary and not by the corresponding secretary.

Kremms advised that the committee might want to consider how to operate, what you do as to not micro manage chair instead create categories and allow the team to operate within that scope of the budget. I have not seen such micromanagement been associated in the past, I think that is propoabely a big enough until Joe B is able to meet with us.

#### Other thoughts?

Leon advised when I objected to pretty sketchy visiting with miles about the work he was doing building technology infrastructure. Messaging through videos, I like the idea, take it or leave it. Website he is building some enhancements to voter data would be beneficial. The price is very modest. My issue is not with miles I like his work no one seemed to know what, there was not a contract and then we found out it, we need transparency. I do not want negative miles or party. I am not interested in walking away and leaving it undone. We do not say the Rules that is a State comm issue. No conversation with the State Comm on this issues, so there is where I see the big problem.

Sandy we did not have a clue about the contract, it might have been the best in the world, but we were not provided information that was agreed and we did not know what the scope of the work was. Chairman has 60 days to provide a budget and then we are to approve that budget as the oversight for the State, we amend or approve. We have not had anything presented to us. There should be specific categories and know how much money is coming in. That has not been presented and we are the oversight comm. And we have a responsibility to the people of the state of oklahom.

Leon I think I appreciate what you are saying.

Sandy it was short time and I understand I was not on the first meeting, there were some communication difficulties and I was not advised. That has been remedied.

Leon, what was the contingency was Proj 46?

Tiffany until next meeting caveat with information relative to line item...when the contract did exist and there we have not even gotten back to a budget. We were first advised, no contract, then there was contract, then the contract was being revised.

Dwayne, any other thoughts.

Sandy why is it taking so long to get a contract, never taken this long. Scope of work, I do not sign until I know, everything I sign, goes through a board of commissioners. Took a long time to get, now it is being revised, we have not been given an amended or revised.

Tiffany, up for revision and they, who is they are remaking more scope and contractual negotiations?

Dwayne: let me take the beginning, it was not intended to be handle that way. I certainly know how that could create dought and concern, we have a contract, we said don't pay contact, we wait and see. We are prepared to move on a new contract...but we decided to and start with a newer contact.

Sandy, I move the budget committee review the new contract by November 19 and we also have budget with incoming and outgoing revenue. Meet again November 22.

Krems I do not see in the state party rules this committee has any authority to approve or disapprove. I think it is dangerous.

Dwayne, may be a bad precedence.

Krems: If we go down that path, then we start having other issues. Which do we review which we not review, my suggest we operate on a higher level and not get into that detail.

Tiffany, this is our job to ensure the budget is approved or not approved and amended.
