19b	Quorum is measured by "members", and quorum is maintained based on the "credentialed number" (making language more in line with Roberts Rules of Order)	YES

19d	*Canadian County Version - Congressional district alternates split between congressional districts, auxiliary groups get alternates	NO	
19e	*Comanche County Version - Minutes kept and filed with respective chairman. OKGOP headquarters cannot require minutes for any reason unless formal notice of a criminal inquiry is also provided	NO	
19e	Minutes kept for all "meetings" (instead of "matters"). Minutes are for review for voters "of that political unit"	YES	
19k	All OKGOP leadership decisions, agreements, actions sent to County and Precinct Chairs within 10 days of the action occurring (including all committees, meetings, business settings, Ad Hoc committees, personnel conducting business in the Headquarters, except disciplinary action which will be sent at the conclusion.	NEUTRAL (Gives more transparency, but as a rule is too broad and undefined)	
19k	Mayes - Officers and committees are allowed to research and provide info to voters prior to elections in official Party communications. Research and communications shall be objective.	NO (this is already allowed and does not need a rule)	
19k	Comanche - No member of a State Executive Committee, County Executive Committee, or State Convention Committee may vote on any issue for which the member is a registered lobbyist.	NO (issues often are not clearly defined; enforcement impossible)

20g	Resolutions sent in 10 days before meetings, minutes must be provided	NO (New Business is a right of committees, minutes should not be a requirement to do business)

10c	Chairman or Vice Chairman has 48 hours to respond to join a call, failing to do so makes the person unavailable. Correspondence logged for Rules Committee and members of Republican Party of OK may read	YES?
10c	If chair or vice chair does not reply to the other's call within 5 days and officers cannot agree	NO
10g	To run for Chairman or Vice Chairman, must give Central Committee 60 days notice	NO
10h	A Chairman or Vice Chairman may only serve two terms consecutively	YES
16c	Not more than one day of business	NO
