OK Turnpike Authority	Cleveland County	OTA barred from any further creation of new turnpikes and the authority itself fully, independently investigated, forensically audited and placed on a path to complete abolition within five years	Pass
Traffic Cameras	Cleveland County	All GATSO and FLOCK Traffic cameras on OK Public roads must be immediately disabled and removed and all related government contracts with these two companies together with enabling legislation dissolved	Pass
