## PETITION FOR RESIGNATION OF BECKY CARSON & RYAN DEATHERAGE

PETITION TO CALL FOR THE RESIGNATION OF BOARD MEMBERS BECKY CARSON AND RYAN DEATHERAGE

We, the undersigned citizens of Oklahoma, respectfully call for the immediate resignation of Oklahoma State Board of Education members Becky Carson and Ryan Deatherage due to their irresponsible and defamatory conduct unbecoming of public officials.

On multiple occasions, Ms. Carson and Mr. Deatherage have made public statements accusing State Superintendent Ryan Walters of displaying inappropriate material on a television screen in his office. These claims, which were widely disseminated
